ORDER:-

Whereas it has come to the notice of the undersigned, who is the competent authority alleging that Sri.K.Suryudu, Molagavalli Village - 2 of Alur Mandal, Kurnool District has not discharged his legitimate duties and adverse news item published as “అక్రమాలకు ఆన్ లైన్” and allegations against the Tahsildar, Alur regarding the entries in online against Sy.No.s 894, Sy.No.864 & Sy.No.924 of Molgavalli Village of Alur Mandal. It is concluded that malafide intention of the Tahsildar cannot be ruled out and violation of Rule No.3 of the A.P. Civil Services (Conduct) Rules, 1964.

And whereas disciplinary proceedings against Sri.K.Suryudu, Molagavalli Village - 2 of Alur Mandal, Kurnool District is contemplated.

And whereas the undersigned after careful consideration of the available material and having due regard to the circumstances of the case, is satisfied that it is necessary to place Sri.K.Suryudu, Molagavalli Village - 2 of Alur Mandal, Kurnool District under suspension pending enquiry.

Now, therefore, in exercise of the powers conferred by sub-rule (1) of rule 8 of Andhra Pradesh Civil Services (CC&A) Rules, 1991, the undersigned hereby place the said Sri.K.Suryudu, Molagavalli Village - 2 of Alur Mandal, Kurnool District under suspension from the date of communication of this order and she shall continue to be under suspension until the conclusion of the disciplinary proceedings relating to the charges.

It is further ordered that during the period this order remains in force the head quarters of Sri.K.Suryudu, Molagavalli Village - 2 of Alur Mandal, Kurnool District shall not leave the headquarters without obtaining the prior permission of the undersigned.

During the period of suspension, Sri.K.Suryudu, Molagavalli Village - 2 of Alur Mandal, Kurnool District shall be paid substance allowance as per FR.53.
